MyMeds has contracted with InnovaHealth, LLC dba InnovaScript to fill and ship prescriptions that are purchased and processed thru our Site(s) and Services at established prices. By accessing and using the Site(s) you agree to and hereby authorize InnovaScript to fill and ship your original prescription. If you desire to have the prescription filled by a different pharmacy (other than InnovaScript), you may call the Innova Toll Free phone number to have the prescription transferred to the pharmacy of your choice. MyMeds cannot guarantee the price of prescriptions filled at other pharmacies. You give us consent to send and disclose to InnovaHealth, LLC dba InnovaScript (and, if applicable to the pharmacy of your choice) all

information provided by you, including without limitation your health care records and other personal and health care information.

#### <u>PAYMENT</u>

You agree that you are responsible for all fees charged by health care providers and InnovaHealth, LLC dba InnovaScript, which MyMeds collects on their behalf. The charges for your access and use of the Site(s) and Services is in addition to the fees charged by health care providers and our contracted pharmacy.
